TERMS AND CONDITIONS (AMUSEMENT PARK)

1. Fitness Certificate from the appropriate authority i.e. GM, CTU & Engineering Department Chandigarh Administration of the complete equipments installed in the Amusement Park on daily basis shall be arranged by the successful bidder on its own.
2. The Firm/Company have to install the electricity connection of its own.

3. The highest bidder will arrange insurance Cover Certificate in respect of each person riding the Amusement Games.
4. All Rules and Regulations of Chandigarh Administration meant for putting up Amusement Games at the above said event, shall be adhered in all respect by the highest bidder.
5. The highest bidder shall ensure that the norms of Chandigarh Administration regarding sound and smoke pollution to be adhered to while plying the equipments.
6. The highest bidder shall submit the Fitness Certificate well before the start of Tourism Department, Chandigarh & as well as on daily basis to the undersigned otherwise you will not be allowed to operate the jhullas.
7. The successful bidder is required to deposit 25% amount of the total auctioned money immediately on the fall of the hammer and 75% amount with a week from the issue of the allotment of contract.
8. In case, the bidder backup after the acceptance of the allotment letter, the total loss to the Tourism Department, Chandigarh will fully be recovered from the bidder.
9. The bidders shall intimate the rates of each Joy ride to be charge from adults and children, separately, as well as time of joy ride etc. along with application before the auction.
10. The area of installation of the Amusement Park will be decided by the Tourism Department, Chandigarh.
11. Any activity other than the said contract, if found carried out by the successful bidder, the entire contract shall be cancelled immediately and the total amount deposited with the Tourism Department, Chandigarh shall be forfeited apart from suitable action as deemed fit shall be initiated.
12. The highest bidder shall ensure the complete cleanliness in and around the Amusement Park.
13. All the cost of tentage material will be borne by the firm.
14. The EMD of the successful bidder will be released after successful completion of the event.
15. The bidder shall not carry any unauthorized activity banned by the government/Chandigarh Administration.

16. The firm if found not abiding by the terms & conditions of the contract, the earnest money will be forfeited and the firm shall be black-listed.
17. In case of any dispute arisen between agency & the Tourism Department, Chandigarh, the jurisdiction shall be Chandigarh.
