- 3. Artists will be engaged for the period of one year.
- Each artist will be paid Rs. 2000/- per shift. In case of team play (Max 2 artists), Rs. 2000/- will be paid to the each member per shift.
- 5. Artist will not take any sought of gift/money from the general public. Artist has to submit undertaking in the department to the effect that he will not accept any sought of gift/money from the general public.
- 6. During the performance in the Parks/Gardens, it should be ensured there is no damage to the lawns and flowerbeds
- 7. The damage at the venue, if any, will be borne by the artist to the discretion of the Department/Manager of the venue.
- 8. Artists will adhere to the guidelines issued by this Department from time to time during the period of engagement.
- 9. Artist will ensure not to allow to disturb the sentiments of general public before/during/ after performance.
- No sound, stage light or any other arrangement will be provided by the Tourism Department, U.T., Chandigarh. Further, no stage, LED, light, Genset etc will be allowed to use by the artist. Only Musical Instrument, small Bluetooth speaker is allowed.
- 11. Artist will ensure not to sing/show any vulgar scene/song etc.
- 12. Artist will ensure not to sing/show any anti social song/dialogue.
- 13. Artist will ensure not to sing/show any anti national scene.
- 14. In case of any dispute, jurisdiction of local courts shall apply.
- 15. The Artist will not use logo or name of the Tourism Department,U.T., Chandigarh in publicity at his/her own level.

- 16. Engagement can be cancelled at any time by the Tourism Department, U.T., Chandigarh.
- 17. Artist(s) can cancel the engagement by giving 30 days written notice to the Director Tourism, U.T., Chandigarh.
- 18. Tourism Department, U.T., Chandigarh can cancel the engagement with the artist immediately on the violation of any of the above terms and conditions and can also blacklist the artist for the period of one year.
