The **reserve price** of the e-auction is **Rs. 6,20,000/-** Inclusive of GST.

**1.1 Minimum Eligibility Criteria**

- The bidder should have valid PAN Number.

- The bidder should have valid GST Number
- The Bidder should not have been blacklisted by any State/Central Government/ Public Sector Undertaking. The bidder should submit an affidavit/undertaking in this regard.

## **1.2 Other Terms & Conditions**

- 1. The Joy Rides-Giant Wheel, Columbus Boat, Break dance, Ranger, Tower Jhulla etc. which are accidental prone should not be allowed.**
2. The electricity connection will be arranged by the party of its own along with safety certificate from Competent Authority.
3. No other stalls except Jhulla and joy rides will be allowed to the successful bidder.
4. Fitness Certificate from the appropriate authority i.e. GM, CTU or Engineering Department Chandigarh Administration of the complete equipments installed in the Amusement Park on daily basis shall be arranged by the successful bidder on its own.
5. The highest bidder will arrange insurance Cover Certificate in respect of each person riding the Amusement Games.
6. All Rules and Regulations of Chandigarh Administration meant for putting up Amusement Games at the above said event, shall be adhered in all respect by the highest bidder.
7. The highest bidder shall ensure that the norms of Chandigarh Administration regarding sound and smoke pollution to be adhered to while plying the equipments.
8. The highest bidder shall submit the Fitness Certificate well before the start of Chandigarh Carnival & as well as on daily basis to the undersigned otherwise you will not be allowed to operate the jhullas.
9. The successful bidder is required to deposit 25% amount of the total bid money immediately on the day of issue of order and 75% amount within 3 days from the issue of the allotment of contract in the shape of Demand Draft /NEFT/RTGS.
10. In case, the bidder backup after the acceptance of the allotment letter, the EMD and the amount deposited shall be forfeitd and suitable action be taken as deemed fit by authority.

11. The area/space for the installation of the Amusement Park will be as per previous practice for which interested bidder may contact office and the area/space will be shown to them physically by the representative of Director Tourism.
12. Any activity other than the said contract, if found carried out by the successful bidder, the entire contract shall be cancelled immediately and the total amount deposited with the Tourism Department shall be forfeited apart from suitable action as deemed fit shall be initiated.
13. The highest bidder shall ensure the complete cleanliness in and around the Amusement Park.
14. All the cost of tentage material will be borne by the firm.
15. The EMD of the successful bidder will be released after successful completion of the event.
16. The bidder shall not carry any unauthorized activity banned by the government/Chandigarh Administration.
17. The firm if found not abiding by the terms & conditions of the contract, the earnest money will be forfeited and the firm shall be black-listed.
18. The agency will adhere to fire safety norms and will install fire extinguishing equipments as per the norms in their respective area of jurisdiction and obtain certificate from the competent authority.
19. The agency will be responsible for garbage management i.e. cleaning, collection and disposal of garbage with sufficient number of dustbins in their respective area of jurisdiction.
20. The agency will adhere to the guidelines issued/being issues by the Govt. from time to time for Covid-19.
21. The insurance & all kind of liability including of all the workers/technicians etc. of contractual agency will be the sole responsibility of the agency.
22. The licensee will erect good quality of swings/games/joy rides. The structural safety and stability of rides including all kind of liability and safety of users will be the responsibility of the bidder.
23. In case of any dispute arisen between agency & the Tourism Department, the jurisdiction shall be Chandigarh.
24. The bidder shall be responsible for any untoward incident during the operating of Jhulla.

### **1.3 Submission of Proposal**

The Bidders shall submit their Proposals/ Bids online in Electronic Format with Digital Signatures. For participation in the above e-tendering process, the Bidders shall have to get themselves registered with <https://etenders.chd.nic.in> and get User ID, Password. Digital Signature is mandatory to participate in the e-tendering process.

Earnest Money Deposit (as mentioned in the advertisement) shall have to be submitted physically in the office of Director Tourism in the shape of Demand Draft in favour of Director Tourism Department, Chandigarh, payable at Chandigarh before the opening of technical bid. In case of EMD is not submitted physically well before time, the bid will be rejected outrightly.

**Soft copy of the demand draft should be uploaded online while applying for the tender.**

Scanned copies of all the documents i.e. technical and financial proposal shall be uploaded as part of the Proposal within the prescribed time limit.
