## 1.1 Minimum Eligibility Criteria

- The bidder should have valid PAN Number.
- The bidder should have valid GST Number.
- The Bidder should not have been blacklisted by any State/Central Government/ Public Sector Undertaking. The bidder should submit an affidavit in this regard.

## 1.2 Other Terms & Conditions

- 1. Area of putting the stalls space will be specified/allotted by the Committee constituted by Tourism Department. The interested parties may visit office on any working day i.e. from 09:30 a.m. to 05:30 p.m. for a site visit. A representative will show the site.
- 2. In case any fake document/invalid document is submitted by the bidder, he/she/entity will be blacklisted by Chandigarh Administration.
- 3. The participation amount/EMD will be refunded to the unsuccessful bidders.
- 4. Separate space with sitting area shall also be allotted to government agencies like CITCO, CIHM and AIHM for setting up of food arena during the festival. This is brought to the knowledge of interested bidders.
- 5. 25% amount of the highest bid should be deposited on the same day of the date of allotment. The remaining 75% amount shall be deposited within 3 next days from the date of allotment in the shape of Demand Draft/NEFT/RTGS.
- 6. Maintenance of hygiene is sole responsibility of party and it should be of the highest standards.
- 7. No music is allowed in the food stalls.
- 8. Fire safety norms shall be followed by the successful bidder.
- 9. The successful bidder shall be solely responsible for food and safety license.
- 10. The quality of the food shall be standardized.
- 11. The successful bidder shall not carry out any unauthorized activity prohibited by the government/Chandigarh Administration.
- 12. Violation of terms & conditions will lead to cancellation and blacklisting.
- 13. In case of any dispute between successful bidder/allottee & the Tourism Department, the jurisdiction shall be Chandigarh.
- 14. The staff engaged by the successful bidder shall also follow principles of hygiene and shall follow the Covid-19 protocols.
- 15. Garbage disposal at the designated locations shall be the responsibility of the successful bidder. No littering shall be permitted and sufficient number of waste bins shall be installed by the successful bidder.
