Reputed interested parties are invited in the e-tender to set up Amusement Park (Jhullas) alongwith an earnest money in the shape of Demand Draft of Rs. 1,00,000/- in favour of **Director Tourism Department, Chandigarh**, payable at Chandigarh or in electronic form via IMPS/ NEFT. The proof of EMD submitted shall be uploaded online while filling up of e-tender.

The **reserve price** of the e-auction is **Rs. 10,00,000/-** Inclusive of GST.

### 1.1 Minimum Eligibility Criteria

- The bidder should have valid PAN Number.
- The bidder should have valid GST Number
- The Bidder should not have been blacklisted by any State/Central Government/ Public Sector Undertaking. The bidder should submit an

- affidavit/undertaking in this regard.
- Experience of participation in atleast one Mega Fairs/Festivals/Melas of National/State repute in the last three years or similar job of equivalent magnitude and scale. The proof of the same shall be attached while uploading the bid. Non submission of proof will lead to rejection of bid at technical evaluation stage.

#### 1.1 Other Terms & Conditions

- 1. All jhullas and rides will be installed only after obtaining Fitness Certificate.
- 2. Where required, adequate safety gear shall be made available to all the participants by the successful bidder.
- 3. The electricity connection will be arranged by the party on its own along with safety certificate from Competent Authority.
- 4. Food stalls shall not be permitted.
- 5. Fitness Certificate from the appropriate authority i.e. Transport Department or Engineering Department Chandigarh Administration of the complete equipments installed in the Amusement Park on daily basis shall be arranged by the successful bidder on its own.
- 6. The highest bidder will arrange insurance Cover Certificate in respect of each person riding the Amusement Rides.
- 7. All Rules and Regulations of Chandigarh Administration meant for putting up Amusement Rides at the above said event, shall be adhered in all respect by the successful bidder.
- 8. The successful bidder shall ensure that the norms of Chandigarh Administration relating to sound and air pollution shall be adhered to while plying the equipments.
- 9. The successful bidder shall submit the Fitness Certificate well before the start of Chandigarh Rose Festival as well as on daily basis to the undersigned. Failure to submit the same shall remit in cancellation of permission to operate the jhullas etc.
- 10. The successful bidder is required to deposit 25% amount of the total bid money immediately on the day of issue of order and 75% amount within 3 days from the issue of the allotment of contract in the shape of Demand Draft /NEFT/RTGS.
- 11. In case, the bidder backs out after the acceptance of the allotment letter, the EMD and the amount deposited shall be forfeited and suitable action shall be taken as deemed fit by authority.

- 12. The area/space for the installation of the Amusement Park will be as per previous practice for which interested bidder may contact office and the area/space will be shown to them physically by the representative of Director Tourism.
- 13. In the event of carrying out of any activity other than the said contract or carrying out of any activity prohibited by law or violation of any terms & conditions by the successful bidder, the entire contract shall be cancelled immediately and the total amount deposited with the Tourism Department shall be forfeited. Other than this, suitable action as deemed fit shall be initiated including black listing of the successful bidder.
- 14. The successful bidder shall ensure complete cleanliness in and around the Amusement Park. Garbage management shall be done properly & adequate number of waste bins shall be installed.
- 15. Entire cost of tentage material will be borne by the successful bidder.
- 16. The EMD of the successful bidder will be released within ten days of the successful completion of the event.
- 17. The successful bidder shall not carry out any unauthorized activity prohibited by the government/Chandigarh Administration in the Amusement Park.
- 18. The agency will adhere to fire safety norms and will install fire extinguishing equipments as per the norms in their respective area of jurisdiction and obtain certificate from the competent authority.
- 19. The successful bidder will adhere to the Covid-19 guidelines in force at the time of event.
- 20. The insurance & other liabilities including that of workers/technicians etc. of contractual agency will be the sole responsibility of the agency.
- 21. The licensee will erect good quality of swings/joy rides. The structural safety and stability of rides including liability and safety of users will be the sole responsibility of the successful bidder/allottee.
- 22. In case of any dispute between successful bidder/allottee & the Tourism Department, the jurisdiction shall be Chandigarh.
- 23. The bidder shall be solely responsible for any untoward incident or mishap resulting from the malfunction of any jhulla or equipment installed or placed by the successful bidder/allottee.

#### 1.2 Submission of Proposal

The Bidders shall submit their Proposals/ Bids online in Electronic Format

with Digital Signatures. For participation in the above e-tendering process, the Bidders shall have to get themselves registered with https://etenders.chd.nic.in and get User ID, Password. Digital Signature is mandatory to participate in the e-tendering process.
